Dear Mr. Barto:

On December 16, 2020, nine (9) competitive bids were received, opened, and read by Downers Grove Grade School District #58 (S.D. #58) regarding the two (2) asbestos abatement projects indicated above. A copy of the bid tabulation is attached. Subsequent discussion with The District regarding the bids and scopes of work followed. The Low Responsible Bid Ranges and Low Responsible Bids for the two projects were as follows:

O'Neill Middle School - Bids Range - \$16,250 to \$33,000 (EHC - \$16,250 - Grinding Method)

Puffer Elem. School - Bid Range - \$47,000 to \$101,700 (EHC - \$47,000 - Solvent Method & Demo)

The apparent low bidder for both school projects was EHC Industries, Inc. (EHC), of Wauconda, Illinois, with bids of \$16,500 and \$47,000, respectively, including submission of all required documents. EHC attended the mandatory pre-bid meeting on December 10, 2020. UAS' review of their bids finds all necessary certifications, schedules, etc. as required in the project manual.

We have contacted Mr. Kevin Cagney of EHC and reviewed their bids and scopes of work, as applicable. EHC stated that they fully understand the scopes of work at the school buildings, the time frames for the projects, manpower needed, site conditions, etc. EHC further noted that they were comfortable and confident with the bids. In addition, UAS adds that their past work experience demonstrates EHC is both competent and capable of performing the work as specified.

Therefore, United Analytical Services, Inc. (UAS) recommends award of both projects to the apparent low responsible bidder for the projects - EHC Industries, Inc. of Wauconda, Illinois.
