## A. Bond Resolution

Member Doshi moved and Member Samonte seconded the motion to adopt the Resolution providing for the issue of not to exceed \$6,000,000 Taxable General Obligation Limited School Bonds, Series 2021A, and not to exceed \$3,000,000 General Obligation Limited School Bonds, Series 2021B, of the District for the purpose of increasing the Working Cash Fund of the District and refunding certain outstanding bonds of the District, providing for the levy of a direct annual tax to pay the principal and interest on the bonds, and authorizing the sale of the bonds to Oppenheimer & Co. Inc. Assistant Superintendent for Business Todd Drafall explained that there are two bond issues: one is an issue of over \$5 million in taxable bonds, which are a refinancing of existing debt; the second is approximately \$3 million in taxexempt bonds, which will pay for smmer 2021 capital projects. These projects include replacing the Pierce Downer School roof and upgrading asphalt and mechanicals at several buildings.
