Legislative Update

The committee discussed the following proposed legislation:

- SB2075: changes the compulsory school age to mandate kindergarten. The District is believed to be in compliance. Possible consideration that required kindergarten will lead to higher enrollment.
- SB1952: Changes the 3% salary cap back to a 6% cap
- HB3606: regarding student data privacy
- SB1798: would like more clarification on "age-appropriate policy on sexual harassment"

The associations are looking for more support to repeal the lowered salary cap, which could impact the teacher shortage. ESP of the Year award has been signed into law. The House will vote on the Dream Act in the near future. NEA is also pushing support of the Keep Our Pact Act, related to federal funding of Title I and IDEA programs.
