Approval of Minutes

Fanny Vlahos moved and Britta Waszak seconded the motion to approve the minutes of the April 14, 2023, committee meeting. Motion carried.

PRESS Issue 112

Dr. Russell noted that the majority of the updates in this PRESS issue are five-year reviews.

- 4:45 Insufficient Fund Checks and Debt Recovery District doesn't have a big problem with debt recovery, but works closely with families to manage repayment. Proposed policy is to enter into intergovernmental agreement with state Comptroller's Office to allow garnishment of tax refunds or other payments from the state. Implementing this policy would incur legal costs to District. This change is not recommended.

Policy 7:270 – Administering Medicines to Students

Policy 7:270 was recently updated to add a paragraph regarding the school district supply of undesignated opioid antagonists (naloxone hydrochloride). However, a necessary paragraph entitled "Void Policy" was inadvertently omitted. The additional language states that this section of the policy is void whenever the District is unable to obtain or fill a prescription for the undesignated opioid antagonists.

The committee agreed that all of these policy updates will be recommended to the Board for approval at the October 9, 2023 board meeting. While they are typically recommended for a first reading by the Board, as there are no substantive changes to current policy language, and IASB will assess a late fee if the changes in the June PRESS Issue 112 are not submitted promptly.
